Dear Allegan County Housing Seeker:

Accessing affordable, safe, and decent housing in Allegan County is not an easy task. The rental market is flooded with numerous households applying for the same units when an apartment or home is advertised “for rent.” Persons who have criminal histories that include felonies, violent, or drug crimes, poor credit histories, limited finances, and unreliable or no transportation face additional barriers to obtaining housing. Unfortunately, there are no immediate housing solutions for those experiencing homelessness in Allegan County.

The Homeless Assistance Programs (HAP) at OnPoint have strict program guidelines that must be met before financial assistance and/or case management services can be provided. To see if you may qualify, please contact the HAP Line at **269-686-4703** or email us at housing@onpointallegan.org. HAP staff will complete an informational screening with you to determine if you may be eligible for our grant-funded programs. Those who are eligible will proceed with an assessment to determine service needs and be assigned to the best program to assist with helping you meet those needs.

Enclosed in this packet you will find helpful information, community resources, a housing list of landlords/apartment complexes including subsidized (income based) rentals, and a worksheet to keep track of your housing search and applications.

Homeless Assistance Program Overview

- The Homeless Assistance Program at OnPoint provides case management and financial assistance for Allegan County Residents who are homeless or are facing a court-ordered eviction in Allegan County. Using housing resources provided as well as outside rental listings, clients with the support of their housing case manager search for affordable housing that meets their needs. In all cases, case managers work collaboratively with clients to develop a plan for affordable permanent housing. Financial assistance is available based on current funding availability and program requirements.

Who Qualifies

- In general, individuals must be homeless, at risk of becoming homeless, or be in a court ordered eviction in Allegan County and meet income limits to qualify to schedule an appointment. See homeless definition below for further information.
 - Homeless definitions
 - Category 1 – Has a primary nighttime residence that is a public or private place not meant for human habitation; or Is living in a publicly or privately operated shelter designated to provide temporary living arrangements (including congregate shelters, transitional housing, and hotels and motels paid for by charitable organizations or by federal, state and local government programs); or Is exiting an institution where (s)he has resided for 90 days or less and who resided in an emergency shelter or place not meant for human habitation immediately before entering that institution.
 - Category 2 – Residence will be lost within 14 days of the date of application for homeless assistance, no subsequent residence has been identified; and the individual or family lacks the resources or support networks needed to obtain other permanent housing.

Information to Bring to Appointment

- If an appointment is scheduled with you, you will need to bring the following information:
 - Proof of household income for the last 30 days (paycheck stubs, award letter, or bank statement showing direct deposits)
 - Proof of emergency (court judgment, homeless shelter verification, eviction letter from people you are staying with)
 - Proof of residency (ID, DHHS Award Letter, Utility Bill, Lease agreement, etc. showing Allegan County Address)
 - Photo ID for everyone over 18 in your household
 - Social Security cards for everyone in your household
 - Birth Certificate for all household members
- If you do not have all your documentation at the time of the appointment, do not let that prohibit you from coming to your appointment. Our staff can assist you to obtain missing documentation.

**Please Note: An appointment with us does not guarantee financial assistance with your housing emergency. **

Emergency Shelter Information

Allegan County does not have an emergency shelter unless you are experiencing Domestic Violence. If you are fleeing DV please call Sylvia’s Place at (269) 673-8700. If you are experiencing homelessness and need shelter, please contact one of the out-of-county shelters listed below to see if they have space available.

Housing Assistance Programs

**Please note that just because a program is listed below does not guarantee that OnPoint currently has funding or availability in that program to assist you. Please contact the housing team directly if you have any questions. **

- **Emergency Solutions Grant (ESG)**
 - Provides Case Management and short-term financial assistance to those who are literally homeless or facing a court-ordered eviction. Financial assistance may include eviction prevention assistance, or assistance with the first month's rent and/or security deposit depending on availability of funding.
 - To be eligible for this program the person must meet all the following criteria:
 - Category 1 or Category 2 homeless, or Facing Court Ordered Eviction
 - Be below 30% Area Median Income for Allegan County
 - Rental Unit must be rent reasonable and under Fair Market Rate for Allegan County
 - Rental Unit must pass Habitability Standard inspection

- **COC Program Permanent Supportive Housing (PSH)**
 - This program combines long term rental assistance with supportive services to help persons maintain permanent housing.
 - Program Participants will have their full rent paid to landlord by OnPoint, however, they will be expected to pay a portion of their income towards rent to OnPoint and pay for their own utilities.
 - To be eligible for this program you must be:
 - Chronically Homeless or Literally Homeless
 - Have a household member with a disability
 - Low-income
 - There are a limited number of program slots available for this funding. When a slot becomes available, case managers use a prioritization protocol to determine who will be offered a slot.
 - Rental units under this program must be determined to be rent reasonable and pass a Housing Quality Standards inspection.

- **COC Program Rapid Rehousing Program (RRH)**
 - This program provides up to 24 months of rental assistance with required case management services while enrolled in program.
 - Program Participants will have their full rent paid to landlord by OnPoint, however, they will be expected to pay a portion of their income towards rent to OnPoint and pay for their own utilities.
 - To be eligible for this program you must be:
 - Literally Homeless
 - Low Income
 - There are a limited number of program slots available for this funding. When a slot becomes available, case managers use a prioritization protocol to determine who will be offered a slot.
 - Rental units under this program must be determined to be rent reasonable and pass a Housing Quality Standards inspection.

- **MDHHS Rapid Rehousing Program (RRH)**
 - Provides Case Management and short-term financial assistance for up to 18 months to those who are literally homeless.
 - Program Participants will have their full rent paid to landlord by OnPoint and will not be required to pay a portion of rent, but they will be responsible to pay for their own utilities.
 - There are a limited number of program slots available for this funding. When a slot becomes available, case managers use a prioritization protocol to determine who will be offered a slot.
 - Rental units under this program must be determined to be rent reasonable and pass a Housing Quality Standards inspection.

- **Supportive Services Only (SSO)**
 - Supportive Services Only is a program that provides light touch case management services to assist level 1 homeless households navigating finding housing. There is no financial assistance provided in this program.
 - To be eligible for Housing Stability Services you must meet the following criteria:
 - Be an Allegan County Resident
 - Be Level 1 Homeless

Subsidized Housing/Income Based Housing Descriptions

- **Rural Development Authority Subsidized Apartments**
 - There are several apartment complexes in the county with subsidized (income based) rent through the Rural Development Authority. These apartments have income limits that limit this assistance to low-income renters. Tenants approved for an apartment in one of these complexes will pay a portion of their income towards rent and utilities.
 - Please see subsidized housing lists for apartment information.
 - Applications for these apartments at each individual apartment site. Applications are subject to each complexes tenant screening process.
 - This type of rental subsidy stays with the apartment complex and is not transferable to another rental.

- **Housing Choice Voucher (HCV) *Formerly known as Section 8***
 - Also known as a tenant-based voucher, this program provides rent subsidies for very low-income renters who find their own housing through private landlords, property management companies, or apartment complexes. Tenants approved for this program will pay a portion of their income towards rent and utilities.
 - The general waiting list for this program is maintained by MSHDA and the designated MSHDA Housing Agent for the County.  - Homeless Preference Waiting List:
 - To qualify to be put on the homeless preference waitlist you must:
 - Be an Allegan County Resident
 - You must be Level 1 or Level 2 homeless per Federal Guidelines. This means living in a place not meant for habitation (Car, tent, emergency shelter) or doubled up and losing your housing within 14 days or less.
 - Verification of your housing situation and county residency, along with identification and social security numbers for everyone in your home will need to be collected by the Housing Team before your name is entered onto the waiting list.
 - This is a waiting list only and does not guarantee you will receive a voucher. If your name is pulled you will still need to complete the

application, provide documentation, and be approved for the program-
by the MSHDA Housing Agent.

- When names are drawn from this list by MSHDA, information on how to apply is mailed to the mailing address provided by the applicant. OnPoint does not control when names get pulled or who gets pulled.
- If you are approved for a voucher, you must then locate and be approved for a rental unit that falls within program guidelines, has a landlord willing to work with the program, and passes a Housing Quality Standards Inspection within the timeframe set by the Housing Agent. Voucher approval does not mean you will have instant housing.

- **Project Based Voucher (PBV)**

- This program attaches rental assistance to specific housing units in the county. Tenants will pay a portion of their rent and utilities based on their income. Applicants must be willing to live in the complex where PBV is available.
- MSHDA's PBV program targets extremely low-income individuals/families meeting the sub populations: At Risk of Homeless, Chronically Homeless, Domestic Violence Victim, Disabled, and other Special Needs as specified. For information on what target populations are eligible for PBV units available contact each apartment complex directly.
- Those seeking to apply for a Project Based Voucher unit should contact each individual apartment complex for more information. OnPoint can assist with Project Based Applications for those who are Category 1 or 2 homeless and enrolled in our housing programs.

Housing Search Worksheet

It is very important to keep a list of the apartments and landlords you apply for housing with so that you can follow up on your application. It is important to update any changes to your address and contact information with each site so that you do not miss crucial mailings or phone calls from landlords.

Application Fees and Security Deposits

Most housing providers charge a non-refundable application fee generally ranging from \$15-50. This fee can sometimes be charged per adult household member. If you feel you have reasons you might be denied such as poor credit, criminal history, or previous evictions it is important to discuss this with the landlord prior to applying and paying the application fee. If you applied and are denied at an apartment complex; request information from the landlord about their appeals process as sometimes you can appeal certain denials. If you feel you have been discriminated against, please contact the Fair Housing Center of West Michigan at 616-451-2980.

Landlords generally charge first month's rent and security deposit to move in. Security deposits can be up to 1.5 times the rent per Michigan Law. *What exactly is considered a security deposit?* Any prepayment of rent, other than for the first full rental payment period established in the lease, and any refundable fee or deposit are considered by law to be part of the security deposit. Sometimes the lease requires that both the first and last months' rent be paid before a tenant moves in. If this is the case, last month's rent would be considered a security deposit. Additional fees or deposits may also be charged to hold the rental property, to run credit checks, for pets, for cleaning, for keys, for mailboxes, for storage, and for other reasons. While these fees or deposits may not be called "security deposits" in the lease, if they are otherwise refundable, they are still considered by law to be part of the security deposit and subject to the strict rules that Michigan has adopted, including the limit on the total amount that a landlord may collect. If they are not considered refundable then they are a separate fee from the security deposit and are not considered part of the 1.5 times the rent limit.

Housing Search Tips

- **Where should you look for housing?**
 - When considering where to look for housing look at factors such as how far you'll be from work, school, doctor's offices, childcare and/or the grocery store. Think about how dependable your transportation is and whether the location is a realistic option for you.
- **How to search for housing:**
 - Online: Facebook Marketplace, Craigslist, Zillow, ForRent.com, ApartmentFinder.com etc.
 - Look in local newspapers, some landlords still advertise the old fashion way.
 - Look for "For Rent" signs as you travel around the county.
- **How much rent can you afford?**
 - Generally, you'll need to budget around 40% or more of your income towards rent.
 - It is recommended that you spend no more than 40% of your total income on housing costs. Housing costs includes rent, utilities, tenant required maintenance, etc. To calculate your affordable housing cost:
 - Take total monthly income X 0.4 = This amount will equal your affordable rent target.
 - We recommend creating a budget of all your expenses going out every month to see if you can afford housing costs with your current expenses.
- **Beware of Scams!**
 - Use the internet with caution. Although craigslist is a good place to find rentals, there are many ads that are scams. If it sounds too good to be true, it probably is.
 - Watch out for listings that do not provide any contact information.
 - Never give out personal information or banking information over email, or the phone.
 - Ask to see the unit before putting any money down on a rental.
- **Watch for Discrimination**
 - Laws prohibit housing discrimination based on race, color, religion, national origin, gender, familial status, disability, marital status, and age.

We will make a check payable directly to the utility company in the amount of \$50.00. The person would need to mail the check with their bill to be posted to their account.

 - Those seeking assistance with rent due to an eviction notice, should bring that statement along with denitrification. The check would be made payable directly to

the landlord in the amount of \$100. The person would either bring the check to the court hearing or give it to the landlord.

When possible, this service is given in conjunction with the person contacting HARA to get long-term assistance and to be placed in housing. This group offers space for queer men to explore and discuss the topics that matter most to us. Queer Men's Community aims to build authentic and lasting bonds throughout this shared experience. Some topics of discussion may include community belongingness, sex and dating, relationships and intimacy, health, gay history, current events and pop culture, identity in the workplace, religion and spirituality, homophobia, oppression, and body image.
 - TRANSCEND is a peer support group for transgender and gender non-conforming / gender-fluid individuals, 18+ and older. The group provides a safe space to talk with one another about experiences, struggles and challenges. This group meets the 2nd Wed from 6:30-8 pm and 4th Sunday from 4:00-6:00 pm of each month.
 - TRANSLATION is a support group for cis partners (18+) of transgender and nonbinary individuals. As a group, Translation strives to provide a safe and supporting environment for partners of transgender and nonbinary people. Translation will provide support, mentoring, resources, education, advocacy, and group social interaction. Meetings will take place the 3rd Sunday of the month from 4-6 pm. This group is a safe, confidential place for people to express needs, victories, concerns, and life experiences. The word translation defined means the process of translating text or words from one language to another -- or moving something from one place to another. This definition connects heavily to the importance of communication, transformation, growth of knowledge, and understanding -- and often this work is shared with others to deepen understanding.
 - TRANSFORMING PARENTS is a peer-led group for parents of trans and gender-expansive people of all ages to build community and support one another on their parenting journeys. Meetings will be the second Sunday of the month, 3-5pm
- Supports for Youth
 - Connections offers an opportunity to meet and share with other gay, lesbian, bisexual, transgender, queer, questioning, asexual, pansexual or allied youth. A safe environment where your individuality and suggestions are respected and you can discuss anything in

confidence. A place for friendship, support, acceptance, education, and access to accurate information and potential resources.

- Big Pride is a partnership with Big Brothers Big Sisters of Southwest Michigan for youth (age 6 to 16) who identify as lesbian, gay, bisexual, transgender, queer, or questioning. LGBTQ+ mentors (Bigs) are matched with LGBTQ+ youth (Littles) to help guide and support them through their teen years. Youth must have parent/guardian support to participate in the program. Regular information sessions are scheduled separately for youth and parents/guardians interested in finding out more about the program and how to apply to be a Big or a Little.
- Host Homes is designed to address the housing needs of LGBTQIA+ youth (ages 13-18) experiencing homelessness. OutFront provides case management care and helps connect youth with caring adults who can provide safe housing and support. - Discord: This private server gives LGBTQIA+ youth a space to hangout, build friendships, provide support for one another, and share the things that make them laugh. This server is monitored daily by Outfront Kalamazoo staff and volunteers.
- Shelter:
 - Legacy House offers transitional housing for LGBTQ+ youth ages 18-24, who are navigating homelessness. They are committed to doing their part to support those in the community affected by the epidemic of homelessness, by providing residents with services, resources, and skill-building to encourage and facilitate healthy, sustainable, and holistic transitions into independence and interdependence.

- Services for Survivors of Domestic Violence (All services are confidential and free of charge)
 - Immediate Support
 - Their trained advocates are available 24 hours a day via our Help Line.
 - Walk-in support is available at their Holland Program Office (411 Butternut Dr.) Monday through Friday, 9am-5pm
 - One-on-One Advocacy (Case Management)
 - Appointments can be set up to meet with an advocate in person or virtually within 24 hours Monday through Friday. Their advocates empower you to meet personal goals, overcome barriers, and provide an opportunity for you to talk and process your next steps. They provide important resources, information, and safety planning, whether you are still in the relationship, are considering leaving, or have already left.
- Services for Sexual Assault Survivors
 - Sexual Assault Exams
 - If you've been sexually assaulted, know that they believe you and it is not your fault. Call their 24-hour Help Line to schedule a free and confidential sexual assault exam. Trauma-informed nurses and advocates are available 24/7 to perform timely and comprehensive exams for adults and teens. Their advocate will guide and support you throughout the process.
 - Sexual Assault Advocacy

- Appointments can be set up to meet with an advocate in person or virtually within 24 hours Monday through Friday. Their advocates empower you to meet personal goals, overcome barriers, and provide an opportunity for you to talk and process your next steps. Their Advocacy services are free and confidential.
 - Trauma Therapy
 - Whether the sexual assault or sexual abuse was three days ago or thirty years ago, trauma therapy can help. In therapy, you will learn coping skills, reduce trauma symptoms, process trauma, and increase feelings of safety. Starting therapy can be nerve-racking but they are there every step of the way. Therapy is free and they don't bill insurance.
 - Support Groups
 - The Sexual Assault support group is meant to be a peer-led safe place for survivors to discuss their experiences, learn coping strategies, deepen your understanding of sexual assault and trauma, and empower you through the power of social support. This group meets Wednesdays from 6-7PM via Zoom.
- Housing Support
 - Emergency Safe Shelter
 - Staffed around the clock, Ginny's Place is a safe and confidentially located residential shelter for adults and children fleeing unsafe homes.
 - Supportive Housing
 - The Supportive Housing program offers individual advocacy and assistance with cost-of-living expenses for families facing homelessness due to domestic violence. This home-based program empowers you to rebuild your safety and stability by helping you find safe, affordable housing while providing support and education.
- Stalking
 - Legal Advocacy
 - Appointments can be set up to meet with an advocate in person or virtually within 24 hours Monday through Friday. Their advocates provide important resources, information on navigating the legal system, courtroom accompaniment, and safety planning. Our Advocacy services are free and confidential.
 - Personal Protection Order Assistance
 - Your safety is important. They can help you walk through the paperwork to file a Personal Protection Order (PPO), both domestic and non-domestic. Walk-in appointments are available at their Holland Program Office Monday through Friday from 9AM-5PM.

Payments are made directly to a utility company, landlord, etc. For some requests it may be necessary to contact additional agencies, landlords, utility companies, etc., to verify information or make payment arrangements.

 - Assistance in locating appliances, furniture, household items, clothing, and various services will be provided as needed.
- Advocacy & Resources
 - Referrals may be made to other agencies and organizations for needs that are better served by those organizations. In addition to material and emotional assistance, one of our founding offerings is spiritual support.
